Part A: Pupil premium strategy plan

Statement of intent

At Dawley C of E Primary Academy we deliver an imaginative and inspiring curriculum with a focus on key skills and independence to ensure our children understand the diversity of the world around us, their place within it and the skills they need to succeed. We offer a creative, challenging curriculum designed to give the children skills and knowledge to help them throughout their lives.

We want our disadvantaged pupils to make good progress and achieve age related expectations. We recognise that the impact of the pandemic has led to an increase in anxiety, isolation and trauma for some pupils. For the next academic year we will focus on addressing gaps that may have been caused by the school disruption during the pandemic through high quality teaching and focussed, measurable interventions, enriching the wider opportunities for our disadvantaged pupils and supporting pupil well-being.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2020 to 2021 academic year.

Attendance 22-23:

Overall attendance for PPG children remained below non-PPG children within the Academy (87.25% compared to 92.08%).

TAs received training and PPG targeted interventions are in place throughout the academic year.

NTP funding has been used to provide targeted interventions across the academy in all classes. Particular focus has been on years 5 and 6 in the autumn term, progressing into other year groups during the spring and summer terms.

Phonics interventions support continue developments in attainment for year 1 pupils.

All PPG children were offered a free place at an after school club by summer term approximately 75% of PPG children were attending a club or accessing an intervention or event. 78% of KS2 PPG children accessed this.

The revamped Attendance Team continues to support all families, with a particular focus on PPG families, to ensure any barriers for accessing school are reduced, in the

form of lifts when needed, supply of uniform and access to both Breakfast Club and After School Club.

A parenting course has been offered to parents, within minimal take-up at present, however this will be offered again during the next academic year and at different times of the year.

The Talk Boost intervention program ran for several KS1 and KS2 groups of children – 100% of children making progress. ELSA support continues for several children in KS1 and KS2 also.

A basic skills approach has been in place for English and Maths, with impact being seen across classes. Lessons have been reviewed and fluency continues to remain a focus in maths. PPG reading in school has been a focus for teachers and the gap with non-PPG at the end of KS2 reading has reduced.

KS1 results showed that PPG children performed better than or in-line with their peers nationally. Compared to their peers nationally (40.2%) 43% of PPG children achieved combined (reading, writing and maths).

At the end of KS2 – PPG children performed better than their peers nationally in reading (76% compared to 60.2%). 41% of PPG children also achieved greater depth in reading (compared to 17.5% nationally). Combined results indicate PPG children are in-line with their peers nationally (47% compared to 44.1%). In writing, 6% of Dawley children achieved greater depth compared to 6.6% of their peers nationally.

A new provision has been created for some children who need additional support to access learning – 75% of children who access this are PPG.
